8. EXTRACT FROM CLUB CONSTITUTION

- 1. It is the responsibility of the Proposer, whom failing, the Seconder to:
 - 1.1 personally attend to the completion of this form.
 - 1.2 introduce the Candidate, if such Candidate be a man, to at least four members of the Board, and if, such Candidate be a lady, to at least four members of the Ladies' Committee. (Club Constitution Paragraph 12.6)
 - 1.3 arrange for the Candidate to play golf with at least two Membership Committee members save where reasons satisfactory to the Membership Committee may exist for waiver of this requirement. (Club By–Laws 1.b. and 1.c.)
 - 1.4 acquaint the Candidate with the history and traditions of the Club.
 - 1.5 inform the Candidate of the Club's dress regulations on the course and in the clubhouse.
 - 1.6 provide a suitable digital photograph of the candidate.
- 2. The Proposer and Seconder must be either Life Members, Full Members or Five Day members of at least two years standing. No member of the Board or Ladies' Committee shall propose, second or sponsor a Candidate. (Club Constitution Paragraph 12.4)
- 3. Except under exceptional circumstances, no member shall propose or second more than two Candidates in any one calender year. (Club Constitution Paragraph 12.5)
- 4. Both the Proposer and the Seconder must have personally known the Candidate for at least two years and preferably longer. (Club Constitution Paragraph 12.5)
- 5. It is desirable that the Proposer and Seconder be acquainted with the Candidate through different circumstances. A Proposer and Seconder from the same business concern is not desirable and is strongly discouraged.
